Service is the Basis of all Worthy Enterprise



MEMORANDUM

Re: Voting in Kingsport, TN

In addition to National Candidates, two items will be on the ballot at the 2020 Ruritan National Convention for delegates to consider. They are outlined below:

The first will add a phrase to Ruritan National Bylaws, **Article IV, Section 2, Item G. Dues Refund.**

G. Ten percent of national dues per year, prorated quarterly for each club member, shall be refunded to that member's district for district expenses, with emphasis on growth, providing the member's club shall have paid its national dues.

(Rationale: To bring bylaws in line with intent of refund.)

The second ballot item will add one sentence to Ruritan National Bylaws, **Article III, Section 3, Item H. Affiliate.**

H. Ruritan Affiliate Members shall be comprised solely of members who have dropped from a local club but want to remain affiliated with Ruritan. Affiliate members will not be associated with any Club or District. The Affiliate Member will not be a voting member. The purpose of Affiliate Membership is to allow members to maintain contact with Ruritan and continue to support this organization. Affiliate member can choose to change to a regular Club member at any time upon approval of a local Club.

(Rationale: To provide clarity of Affiliate Members' voting rights.)

A grandmother's story.....



Eleven years ago, I received a phone call from my son which forever changed my life. He started the conversation by asking, "How would you like to be a grandmother?" At that time, I had no experience at being a grandmother. So, I hesitantly replied, "Wow! That sounds good." Then, the next question completely caught me off guard, "How about tomorrow?" My answer then was, "Wow!" and, since that moment, our lives have been full of fun times and "Wows!"

From the moment we saw Sarah, we fell in love. This baby girl, our first granddaughter, was beautiful. We held her, oohed and ahed over her, watched her grow and took lots of pictures. She was the light of our lives. Then, when Sarah was about a year old, our son and daughter-in-law surprised us again. They were expecting another child – this time their natural-born child. We anxiously awaited the birth of James, who was born 19 months after Sarah joined our family. We were truly blessed!

As it turned out, God was ready to truly bless our family again. Around the time of James' birth, our son and daughter-in-law received an unexpected call themselves from Sarah's caseworker. Sarah's natural mother was pregnant again and had requested that they also take this baby into their home. She was having another girl and wanted the two girls to grow up together as sisters. Well, their immediate reaction was there was no way this could happen. They had a one and a half year old child and a new baby they had just brought home from the hospital, cramped living quarters, too many diapers, not enough time, and very little energy. So, they politely said, "No," and hung up. But, within just a few minutes of hanging up, they knew exactly what they needed to do. They returned that call and agreed to be Mommy and Daddy to baby #3. Sweet Grace was born exactly six months after her brother James. It was quite fun watching them grow up together and observing as big sister Sarah tried to supervise.

Looking back on the ways God has blessed our lives is truly amazing! I never really dreamed about being a grandmother, but now I couldn't imagine life any other way. My husband and I thoroughly enjoy all of our grandchildren. Each one of them is special and each has their own unique personality, talents, and interests. I am so very proud of each of them and love them all beyond measure.

I am also so very proud of my son and daughter-in-law for the wonderful parents they have become and the great wisdom they have shown. Yes, that phone call eleven years ago changed all of our lives, and I am so glad it did. I could not imagine life any other way! I thank God every day for our precious blessings!

Casey.....

I have always had a heart for children who were unwanted by their birth parents, so perhaps it is no surprise that Jim and I found ourselves as foster parents even though we already had a house full of our own. Jim and I both had been married before and I had four children by my first marriage and Jim had two. My kids lived with us, however Jim's were only with us through the summer months. Jim and I did choose to have a child together, so our family size was a bit large. After several years as foster parents we reached a time when we questioned whether it was wise for us to continue and after much prayer we decided that God had gotten us into this so we would once more rely on Him to help with the decision. Very shortly after this prayer we received a call from social services saying they had two infants that needed placement. One was a girl whose mother was on drugs and the infant was experiencing withdrawal and would be placed back with the mother when they felt she was ready. The other infant had been abandoned by the mother and wrapped in an orange towel, placed in a basket and set outside the entrance of the Casey Clinic in Alexandria, Va. My heart was drawn to this abandoned infant and after discussion with Jim and our children we decided to take the abandoned infant.

When the social worker brought Casey Alexander, the name the agency chose for him, to our home the sensation I received when she handed me this tiny little bundle was very similar to the sensation I received when each of my children as infants was handed to me! It was a very overpowering feeling. When we brought this little bundle to our pediatrician for his first visit, the doctor looked at me and said "are you keeping this one?" Casey was well accepted by all of his new siblings and he continued to grow more precious daily. When he was 11 months old he was released for adoption, which at that point we mentioned that we would be interested in adopting Casey. They told me then that because they were not an adoption agency their only concern was to find a good home for Casey unlike an adoption agency that is attempting to fulfill the wishes of two people looking for a child of their own. I saw this as a sign from God that Casey was meant for us. We knew adoption could be an expensive thing and we also knew we did not have a lot of money, so we did some more praying. We learned that we could do all the paper work and application for adoption without hiring an attorney, however wording had to be precise in order to be considered. We did all that was necessary and discovered by doing it ourselves the application fee was about \$60 and that was it. So in October, a day before Jim's birthday, the judge signed the paper saying Casey was now legally our son. I sent for his birth certificate immediately and it arrived on my birthday in February. As I opened it, I thanked God for this gift that we knew was from God, just as each of our children were. Casey is now an architect, married to a precious young lady who has a law degree, however she is a homemaker at present with three amazing children. God is indeed good!

First Lady Nelda's Adoption Awareness Program

Shannon Shepherd, speaker at First Lady Nelda's Breakfast, shares her adoption story.



Shannon.....

My childhood started out very typical (in my view). I had a mother and father. I was the oldest of three girls. My dad worked, and my mom was home with the three of us. But when I was in the first grade, something happened. I was too young to understand. I still don't fully know. I do know that moment began a chain of events that were tough, emotional, and many times beyond my control.

We moved out of our home and into another house. Not long after that, I remember hearing that my mom was "sick" and then she was gone for a few days. Then, it wasn't too long before we were evicted from our house. It was the first time I lost everything I owned. I remember my maternal grandparents came and picked up the three of us and our biological mom. I will never forget being in the back of my granddaddy's car, up on my knees looking out the back window, crying and begging him to stop because my dog was running after us as fast as she could. It seemed to me like she knew we were leaving, and that we weren't coming back.

We lived with our maternal grandparents for a short while. I'm not sure why, but we ended up moving in with two of my paternal aunts. One day at school, they called me to the office. When I went in the office, there was a police officer and some other people (social workers, I'm sure). They loaded us up into the police car and took us away. This would be the second time in my life that I lost everything I owned, except this time, I lost my parents. They took us to a group home that had boys and girls of all ages.

I'm not sure how long we were in the group home. We were eventually returned to our biological parents, and we moved to Virginia. My dad spent time in and out of jail. Around that same time, my mom got "sick" again, but this time, it was worse. She was scary. She slept all day. At night, she would walk around the house, in the dark, talking to herself. Many days, the only thing we had to eat was school lunch. We were often cold in the winter, because we couldn't afford heating oil.

One day, while I'm sitting in my favorite 4th grade teacher's class, I get called to the principal's office. In the principal's office, I find a police officer and our social worker. They load us in the police car and take us to a foster home. This is the third time I've lost everything I own, second time I've lost my parents. And I start over again with my eleventh school.

Our foster parents were okay. Eventually, I was told by our social worker that "we were too much for them" and that she was looking for a new home for us. That's when the reality hit me—my sisters and I could be separated. Already, I'm not even 10-years-old, and I've lost everything I owned three times, my parents twice, and now there's a chance that I am going to lose the two things that mean more to me than all those things combined.

One day the phone rings. It's our social worker, and she wants to talk to me. She tells me that she has exciting news for me. She has found a home for all three of us...and it's with someone we already know! We were so excited to find out that the gym teacher at our former school wanted us, and that we were going to be living with her! It was truly a miracle. It was all I had hoped for.

The three of us thrived in the care of our foster/adoptive family and life was relatively uneventful. I knew that I had a life with them that I would have never had with my biological parents. I am positive that our lives would have gone down a very different and troubled path if we had not been removed from our biological parents.

I had my oldest son shortly after graduating from college, which is what led to my sisters and I being formally adopted. We changed our names to our foster/adoptive parents name when we entered permanent foster care. But on my son's birth certificate, they asked for my name as it appears on my birth certificate, and I did not want to use that name! So, they decided to adopt the three of us at that point. When we went before the judge, he said, "This is the first time I've ever had three grown adults asking to be adopted."

About 10 years ago, I received a phone call from my sister letting me know that our biological mom had lung cancer. The cancer had spread to her brain, and she was going to have surgery to remove a tumor from her brain. Her prognosis was that she would live for about three months, if the surgery was successful. We became reacquainted with our great-aunt and cousin during this time. They invited us to come have supper and asked us if there was anything they could do for us. I asked for pictures.

Now, I need to go back a little bit to tell the rest of this story. Our foster/adoptive parents ensured that we were at church every Sunday. Early on in church, I read a Bible verse that quickly became my favorite: I Corinthians 13:4-8, 13:

"⁴ Love is patient, love is kind. It does not envy, it does not boast, it is not proud. ⁵ It does not dishonor others, it is not self-seeking, it is not easily angered, it keeps no record of wrongs. ⁶ Love does not delight in evil but rejoices with the truth. ⁷ It always protects, always trusts, always hopes, always perseveres. ⁸ Love never fails. ¹³ And now these three remain: faith, hope and love. But the greatest of these is love."

Having hope for the future, faith that there will be a better tomorrow, and knowing I am loved and have someone to love--- those are the things I cling to.

But back to my great-aunt's house. She came in the living room, carrying a boxed set of photo albums. She sat them down on the table and imagine how excited I was to see that one album said "Faith," one said "Hope," and the other said "Love." I commented on how much I liked them. My aunt responded, "I could hardly believe it when I found these albums for you all. Your mom always said that you three girls were her "faith, hope, and love." I was speechless. I knew right then that my mom, the mom before schizophrenia stole her from us, had always been with me, and that she always would be.

However, just before docking, the captain announced that we would be leaving Bermuda the next morning instead of late afternoon. Smart decision! Eight hours later we were in 6-8' seas and 30 mph winds. Overnight, seas got to 12-14' with gust of 60+mph. Yes, you worked your sea legs going anywhere in ship. Things that were very stable earlier on the cruise ended up on the floor (I saw one stack of plates go sailing across the floor). After the two-day sail back to Baltimore, our trip was over. Seems like everyone had a great time and look forward to the next Ruritan cruise.

Since summer is now over, I know every club is busy with their fundraising projects, getting ready for the district conventions, and the upcoming Ruritan National Convention in Kingsport, TN. Remember auction items for the RNF auction at the National Convention in Kingsport and your local district conventions. A lot of the fundraising for the RNF is locally through the districts and local clubs donating items for district convention auctions. Soon you will be setting your club's budget for 2020. Please remember the Ruritan National Foundation with a line item for both the \$300 BY\$ deposit and donation to an education fund. To increase the security of the personal data on the Ruritan Member Management System (MMS) all users will need to update/change their passwords every six months. You may change your password at any time using the method explained in this article. If you fail to do that, you will be required to do so on February 1, 2020.

Any user logging on to the MMS now will see the following message:


Please note that on 02/01/2020 you will be required to change your MMS password, if you have not done so in the last 6 months. Going forward, your password will have to be changed every 6 months. This is being implemented to ensure that your personal data within MMS remains secure. If you desire, your password can be changed before 02/01/2020 and you will not be prompted for another 6 months. Thank you for your cooperation.

To change your password, go to your home page and choose the security option (gold coin in upper right of menu.) This will bring you to a screen where you enter your current password and then can choose a new password, entering it twice. Be sure to click on the "update" button to make sure your change is accepted. The two graphics on this page show how those two screens look.

Every Ruritan member has a right to access the MMS and see his/her data. Please do not share passwords with another user. Encourage them to set up their own password. 

Belmont/Belmont Club of Women Host Horse Show

This article originally appeared in an August 2019 issue of the Orange County Review. Gracie Hart Brooks gave permission to reprint.

In central Virginia, August brings the beginning of the school year, final trips to the beach, the Perseid meteor shower and in a corner at the junction of Orange and Spotsylvania counties, the Belmont Horse Show.



This year marked the 79th of the event which the Belmont Club of Women and the **Belmont** Ruritans have presented almost every year since 1936. There only have been three years the show wasn't scheduled—one during World War II, once for a death in the landowner's family and a final time when it rained on both the day of the originally scheduled show and the chosen rain date.

Since its inception, the Belmont Horse Show has been a fundraiser for the two clubs. In 1936, the club conceived the idea of a horse show to raise \$35 to provide a home nurse for a local resident. The original show was a success, raising more than \$50 and in recent years the show has netted the groups thousands of dollars, with the highest profits (\$9,000) coming from the 2018 show.

Unlike most modern horse shows which feature multiple sand rings, the Belmont show is held in one all-grass ring with large trees in the center. The show has classes for young and old, English and Western riders, driving, games and costume classes.

Entries are inexpensive--\$5 for ponies and \$10 for horses for any number of classes. Admission to the grounds is \$10 for adults and \$5 for children. Most other horse shows don't charge admission, but entries range from \$12 to \$25 per class. At Belmont, an adult with a horse can enter one or 16 classes for \$20 (\$10 entry and \$10 grounds admission) and a child with a pony can do the same for just \$10.

John Marsh, president of the Belmont Ruritan Club said the horse show is a summer tradition and successful fundraiser for the club.

"Our horse show is a real tradition," he said. "We've been doing this since 1936. People can come show their horses, get a really good lunch—our jambalaya is great—have an ice cream cone or a piece of home-made pie."
